PENALTIES: False Sweating. A person to whom a lawful oath or affirmation has been administered or who executes a document knowing that it purports to be an acknowledgment of a lawful oath or affirmation commits the offense of false swearing when, in any matter or thing other than a judicial proceeding, he knowingly and willfully makes a false statement under Code Section 16-10-71. A person convicted of the offense of false swearing shall be punished by a fine of not more than \$1,000.00 or by imprisonment for not less than one nor more than five years, or both.

Part Three: Statement of Facts

I believe that Smyrna City Councilmember for Ward 3, Maryline Blackburn violated the Georgia Ethics in Government Act by:

- 1) Failing to disclose in-kind and/or expenses for her campaign office located on Concord Road on her campaign disclosure reports, and,
- 2) Exceeding in-kind contribution amounts for that office space if it was indeed an in-kind contribution, and,
- 3) Repeatedly omitting address and employer information on several campaign reports for donors, only reporting a name and dollar amount, and,
- 4) Seemingly failing to file several campaign finance disclosure reports.

I have included several Personal Financial Disclosure Statements as well as Campaign Contribution Disclosure Reports for examples, which also include the list of the campaign office. Also enclosed is a screenshot identifying the Concord Road office as the "campaign headquarters".
